who have a friend or family member with dementia, or who are worried about developing dementia themselves.


'About dementia' is designed to help more able people with learning disabilities who want to understand and talk about dementia.


This easy read resource can be used by staff and carers with people with learning disabilities to help them understand about end of life choices, dying and death.
